

If you were placed in administrative segregation in a federal penitentiary you may be entitled to receive money.

WHAT IS THIS ABOUT?

Three separate class actions lawsuits have ended with the Courts finding that the rights of inmates placed in administrative segregation while incarcerated in federal penitentiaries were violated. A global award of approximately **\$28 million** is available to pay all eligible claimants, known as Class Members, who make a claim. Additional money may be claimed by eligible Class Members in some cases.

NEW DEADLINE FOR MAKING A CLAIM

Important: The deadline for making a claim was extended by the Court, from September 7, 2022 to November 7, 2022. All claims must be received by the Claims Administrator, **NO LATER THAN NOVEMBER 7, 2022**. If a paper Claim Form is used, the postmark on the envelope will be considered as the day the Claim Form was submitted to the Claims Administrator.

WHO CAN CLAIM?

Make a claim if either:

<p>Option A</p> <ul style="list-style-type: none"> ✓ You stayed in Administrative Segregation in a federal penitentiary anywhere in Canada ✓ for 16 consecutive days or more ✓ AFTER March 3 2011. 	<u>OR</u>	<p>Option B</p> <ul style="list-style-type: none"> ✓ You stayed in Administrative Segregation in federal penitentiary anywhere in Canada ✓ For any length of time ✓ AFTER July 20 2009 ✓ AND you were diagnosed by a medical doctor with a mental disorder or a borderline personality disorder prior or during your incarceration <u>AND</u> you suffer(ed) serious impairment as a result of your disorder and reported such to Correctional Service of Canada (CSC).¹

All administrative segregation placements count, even if they were recorded as “voluntary”.

HOW DO I MAKE A CLAIM?

You must fully complete the Court-approved Claim Form. To get a Claim Form you have three (3) options:

WHAT ARE MY OPTIONS?

Submit a Claim Form	If you want to receive money, you MUST SUBMIT a Claim Form to the Claims Administrator NO LATER THAN NOVEMBER 7, 2022 .
Do Nothing	If you do not make a claim, you will not get any money and you will give up the right to get money in the future.
